2.1. This Event will count for:

4. ELIGIBLE VEHICLES

4.1. The Latvian National Cup Event is open to vehicles which is participate in National championships for autocross in division:

2000Super - FWD or RWD cars with engine capacity till 2000 cm3

4.2. Each car will be accompanied by a National Technical Passport.

5. ELIGIBLE COMPETITORS

Any person or body holding a National or International Drivers Licence.

6. ENTRY FORMS – ENTRIES

6.1. Anybody wishing to take part in the Event must send the attached entry form duly completed to the Secretariat before **18.05.2018**.

6.2. There will be only one driver per car, and no driver may compete in more than one car at the Event.

6.3. The maximum number of entries for a Support race will be 20.

7. ENTRY FEES

7.1. The entry fee is:

a) 1st closing date of entries: 100 € (Entry fee 50 € + 50 € paddock fee – all included)

b) 2nd closing date of entries: 200 € (Entry fee 150 € + 50 € paddock fee – all included)

As the Entry Form from the Driver and the Confirmation of the acceptance from the Organiser is considered as a contract, the Driver, not coming to the Event, has to apologise giving the reason as soon as possible. **The Entry Fee will be paid at the Administrative checking .**

8. INSURANCE

8.1.The organizer will provide for an insurance policy by **AAS BALTA** , which covers the competitor's liability for civil responsibility toward third parties.

8.2.Liability insurance Sums insured is EUR 500.000 total coverage.

10.2 Noise

For all cars, a limit of 100 dB is imposed.

V. RUNNING OF THE EVENT

14. QUALIFYING

There will be 6 laps in each qualifying heat.

15. FINALS

There will be 7 laps in the Finals.

VI. RESULTS – PROTESTS

20. PROTESTS – APPEALS

20.1 All protests will be lodged in accordance with the Latvian ASN Code.

All protests must be made in writing and handed to the Clerk of the Course or his assistant, or in their absence any of the Stewards of the meeting, together with the sum of € 200. If the protest requires the dismantling and re-assembly of different parts of a car, the claimant must make a deposit of € 1000.

VII. PRIZES AND CUPS

21. PRIZES

The prize-giving will take place at “Mūsa Raceland” ..

First three places in **Super 2000** will be rewarded with cups and rewarded with award.

VIII. OTHER INFORMATION

22.FIRE EXTINGUISHERS

Each driver is responsible for ensuring that a single piece extinguisher of minimum 5 kg is available within his own team area inside the paddock.

23.PROTECTION OF THE ENVIRONMENT

Each driver is requested to ensure that a plastic sheet (minimum dimensions 4 metres by 5) is spread on the ground in the place reserved for his team where work is to be done on his car, in order to prevent any pollution in case of an accidental leak, etc.

24. DRIVERS’LIAISON OFFICER

The Drivers’ Liaison Officer will be recognisable by special red vest.
